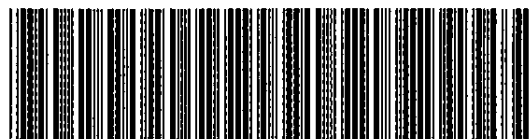

ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes,  
Adopts the following Articles of Incorporation of such corporation:

ARTICLE I

ARTICLE II

The period of the duration of this corporation shall be perpetual, unless dissolved according to law.

ARTICLE III

- A. The purposes of which said organization is organized are exclusively religious, charitable, scientific Literary, and educational within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

## ARTICLE VII


