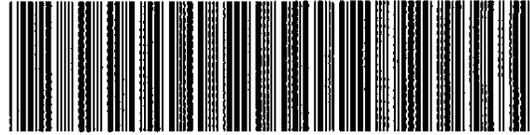

## **Articles of Incorporation**

In compliance with Chapter 617, F.S., (Not for Profit)

### **Article 1—Corporate Name**

The name of the corporation shall be

**Altruist Knights, Inc.**

### **Article 2—Principal Office**

The mailing address and street address of the principal office of the corporation is

**2398 Bridge Creek Road, Marianna, Florida 32448.**

### **Article 3—Purpose**

Section 1. The purposes for which this organization is organized are exclusively charitable and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. For further details, see Article I of the Bylaws.

Section 2. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Section 3. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, as per Article XVIII of the governing bylaws. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

### **Article 4—Manner of Election**

The manner in which the directors are elected and appointed are stated in Article IV of the Bylaws.

### **Article 5—Initial Officers and/or Directors**

Management of the affairs of the corporation is to be vested in its Board of Directors whose operations in governing the corporation shall be defined by the organization's Bylaws. The number of directors constituting the board shall be a minimum of five. The names and addresses of the persons who are serving as directors until their successors are elected and qualified are set forth below:
