ARTICLES OF INCORPORATION OF MT. PLEASANT AFRICAN METHODIST EPISCOPAL CHURCH OF FRUITLAND PARK, FLORIDA, INC.

ARTICLE ONE Name

The name of the corporation shall be Mt. Pleasant African Methodist Episcopal Church of Fruitland Park, Florida, Inc.

ARTICLE TWO Principal Office

The principal place of business for this corporation shall be:

2433 Spring Lake Road Fruitland Park, Florida 34731

ARTICLE THREE Purpose

The specific purpose for which the corporation is organized is as follows:

- A. The general purpose of this corporation is to foster and encourage religious worship in accordance with the principles of the African Methodist Episcopal Church; that it shall purchase, take, receive, lease take by gift, devise or bequest, or otherwise acquire, own, hold, improve, use, or otherwise deal in and with real or personal property, or any interest therein where ever situated, in trust, for the use and benefit of the African Methodist Episcopal Church, Inc. It shall have the right to make conveyance of its property in accordance with the rules of the general body of the African Methodist Episcopal Church and the current edition of *The Book of Discipline of the African Methodist Episcopal Church* or its successor; it being understood that said corporation shall not be required to accept any such donations or gifts not in harmony with the purpose and object of said corporation.
- B. Said corporation is organized exclusively for charitable, religious, educational and scientific purposes including, for such purposes, the making of distributions to organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code.)
- C. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers of other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(3)(3) purposes. No substantial



part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

D. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal Tax Code.)

ARTICLE FOUR Term of Existence

The corporation shall have perpetual existence, unless it becomes in conflict with the laws of the African Methodist Episcopal Church as found in the current edition of *The Book of Discipline of the African Methodist Episcopal Church* or its successor, and is dissolved in the manner provided by law. In the event of dissolution of the corporation and after the payment of all debts, monies or assets remaining shall not inure to benefit of any individual, but shall be held in trust by the Central Annual Conference of the Eleventh Episcopal District of the African Methodist Episcopal Church.

ARTICLE FIVE Election/Appointment of Trustees and Directors

The Board of Trustees and Directors shall be appointed in accordance with the current edition of *The Book of Discipline of the African Methodist Episcopal Church* or its successor.

ARTICLE SIX Bylaws

The Bylaws that will govern this corporation are the laws as are encroached in *The Book of Discipline of the African Methodist Episcopal Church* or its successor, and such amendments to said book, as is revised and compiled by the General Conference of the African Methodist Episcopal Church, Inc. periodically and thereafter.

ARTICLE SEVEN Powers

The powers and responsibilities of the corporation are limited by the rules and regulations of the African Methodist Episcopal Church, Inc. and the current edition of *The Book of Discipline of the African Methodist Episcopal Church* or its successor.
