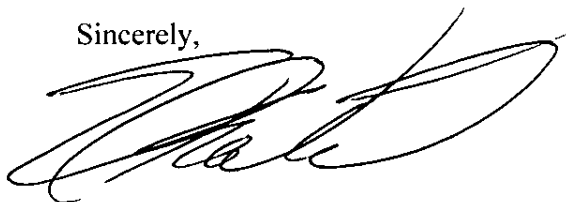

**ARTICLES OF INCORPORATION
OF
TAMPA HAWKS, INC.
A FLORIDA NOT FOR PROFIT CORPORATION**

The undersigned person, as incorporator of a corporation not for profit under the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation for the Corporation:

**Article I
Name and Principal Address**

The name of the coporation is Tampa Hawks, Inc. The initial principal address and mailing address of the corporation is c/o Marc Yonker, 601 West Swann Avenue, Tampa, FL 33606.

**Article II
Purposes**

This corporation is organized exclusively for educational purposes and to foster national amateur sports competition, including the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code.

**Article III
Term of Existence**

The corporation shall have perpetual existence.

**Article IV
Board of Directors and Officers**

a. The names and addresses of the initial directors of the corporation are:

b. The directors shall be appointed as provided in the bylaws of the corporation.

d. The persons named as initial directors and initial officers shall hold office for the first year of existence of this corporation or until a successor is elected or appointed and has qualified, whichever is first.

Article V Corporate Net Earnings; Activities

a. No part of the net earnings of the corporation shall benefit or be distributed to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof.

b. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

c. Notwithstanding any other provision of these articles of incorporation, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code.

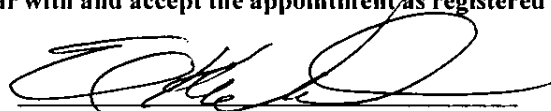
Article VI Dedication of Assets; Distribution on Dissolution.

The assets of this corporation are irrevocably and permanently dedicated to the purposes set forth in Article II. Upon the dissolution of the corporation, its assets shall be distributed for one or more exempt purpose(s) within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as such court shall determine that are organized and operated exclusively for such purposes.

Article VII Registered Agent, Initial Registered Office

The name of the registered agent of the Corporation is Elise K. Winters. The address of the initial registered office of the Corporation is 1006 Drew Street, Clearwater, FL 33755. The Board of Directors may move the registered office or the principal office to any other address in Florida.

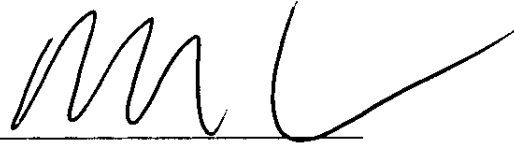
