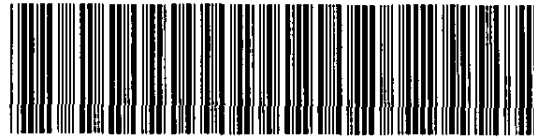

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, acting as incorporator (s) of a corporation pursuant to chapter 617, Florida Statutes, adopt (s) the following Articles of incorporation.

ARTICLE I - NAME

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The specific purpose for which the corporation is organized:

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in these Articles.

ARTICLE X - GENERAL LIMITATION ON NONPROFIT ACTIVITIES

Notwithstanding any other provisions of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.
