
Amendment to Article III as follows

**ARTICLE III
PURPOSES**

The Bigger Pitch Foundation, Inc. (the "Corporation") is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, and to the extent permitted by the Internal Revenue Code, to assist in the development and education of people through the use of sports and nature.

There are no members or members entitled to vote on the amendment. The amendment was adopted by the board of directors.
