## **ARTICLES OF INCORPORATION**

In compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLE I NAME**

The name of this corporation is RENEW FOR CHRIST, INC., a Nonprofit Florida Corporation.

### **ARTICLE II TERMS OF EXISTANCE**

The corporation shall have perpetual existence.

### **ARTICLE III PRINCIPLE OFFICE**

The corporation's principal place of business shall be 2970 S.E. 2<sup>nd</sup> S.T, Boynton Beach, FL. 33435

### **ARTICLE IV PURPOSE**

This corporation is organized exclusively for charitable and religious purposes within the meaning of section 501(c)(3) of the Internal Revenue code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. More particularly, to conduct programs and activities, sponsor research, sponsor promotions, raise funds, request and receive grants, gifts, contributions, dues and bequests of money, real and personal property; or acquire, receive hold, invest and administer, in its own name, securities, funds, objects of value, or other property, real or personal; and make expenditures and distributions to or for the benefits of the RENEW FOR CHRIST, Inc

Furthermore, this nonprofit Christian corporation will provide residential, social, emotional, developmental and spiritual support to individuals who are in recovery and need assistance transitioning back into life as a responsible citizen.

### **ARTICLE V MANNER OF ELECTION AND BY LAWS**

The Board of Directors by two-thirds vote is authorized to establish bylaws for the corporation not inconsistent with these Articles of Incorporation, and to amend same from time to time. Directors shall be appointed by a unanimous vote of the Board of Directors. The program Director shall be appointed by a unanimous vote of the Board of Directors. All other officers shall be appointed as necessary by the Program Director.

## **ARTICLE VII TYPE OF NON PROFIT CORPORATION**

The corporation is not for profit and is a public benefit and Christian Corporation.

## **ARTICLE VIII INDEMNIFICATION**

The corporation does indemnify any directors, officers, employees, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable statute.

## **ARTICLE IX PUBLICLY SUPPORTED TAX EXEMPT CORPORATION**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

## **ARTICLE X DISSOLUTION**

Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.
