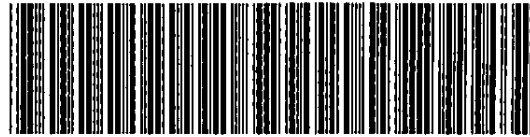

Articles of Incorporation For WELCOME TO JUDAISM, INC.

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

Article I

The name of the corporation is:

WELCOME TO JUDAISM, INC.

Article II

Article III

The specific purpose for which this corporation is organized is:

PROVIDE FOR PHYSICAL AND SPIRITUAL NEEDS OF ALL JEWS,
REGARDLESS OF RELIGIOUS BACKGROUND OR AFFILIATION. PROMOTE
THE FUNDAMENTAL AND ENDURING PRINCIPLES OF JUDAISM AND TO
ENSURE THE CONTINUITY OF THE JEWISH PEOPLE AND PROVIDE A
MEANS OF JEWISH WORSHIP.

SUBJECT TO ANY RESTRICTIONS IN THE ARTICLES OF INCORPORATION,
THE CORPORATION MAY ENGAGE IN ANY LAWFUL ACTIVITY
CONSISTENT WITH ITS TAX EXEMPT STATUS FOR WHICH NOT-FOR-
PROFIT CORPORATIONS MAY BE ORGANIZED IN THE STATE OF FLORIDA.

Article IV

Said Organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the

Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the Corporation shall inure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporation assets on dissolution of the corporation.

No substantial part of the activities of the Corporation shall be the carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by IRC §501(h)), and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

Notwithstanding any other provision of these articles, the corporation is organized exclusively for one or more of the following purposes: religious, charitable, scientific, testing for public safety, literary or educational purposes, or to foster national or international amateur sports competition (but only if no part of its activities involve the provision of athletic facilities or equipment), or for the prevention of cruelty to children or animals, as specified in section 501(c)(3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501(0)(3) of the Internal Revenue Code of 1954.

In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another organization exempt under IRC §501(c)(3), or corresponding provisions of any subsequent Federal tax laws, or to Federal government, or state or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of Florida.

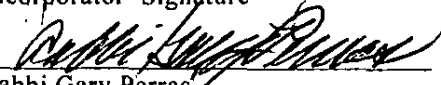
