



Articles of Incorporation

Tampa Music Society, Inc.

Article 1. *Name of the Corporation*

SECRETARY OF STATES
TALLAHASSEE, FLORIDA

The name of the corporation is: Tampa Music Society, Inc., and is organized under chapter 617, Florida Statutes, as a corporation not-for-profit.

Article 2.

Duration of the Corporation

The corporation shall have perpetual existence unless sooner dissolved or terminated at law.

Article 3.

Purpose of the Corporation

The purposes for which the corporation is organized are exclusively literary, educational, scientific, and charitable purposes or for any one or more purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1954, or the corresponding provision of any successor United State Internal Revenue law.

The corporation, in order to implement these purposes, shall develop, promote and produce music performances to raise funds and awareness on behalf of other not-for-profit organizations that are based out of Central Florida that will immediately benefit the Tampa Bay region. These purposes shall be broadly interpreted to allow the corporation flexibility in engaging in all activities that promote the interests of the corporation, so long as the same do not adversely affect the corporation's tax-exempt status for federal income tax purposes.

The corporation may engage in fundraising activities to fund its operations and for other charitable purposes. No part of the earnings, if any, of the corporation shall inure to the benefit of any private shareholder, member, or individual, and no substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, except when permitted by the Internal Revenue Code.

In event of dissolution of the corporation, the residual assets of the corporation shall be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or the corresponding Sections of any future Internal Revenue Code, or to the federal, state, or local government for exclusive public purpose.

Article 4.

Membership in the Corporation

The members of the Board of Directors shall constitute the membership of the corporation.

Article 5.

Directors of the Corporation

Section 5.1—*Number of Directors*

The number of Directors constituting the Board of Directors shall not be less than three. The Board of Directors may change the number of Directors to sit on the Board, but at no time shall that number be less than three. The initial Board of Directors shall be made up of four Directors, whose names and addresses are listed in Section 5.3.

Section 5.2—*Election of Directors*

The manner of election of Board Members and their terms, along with the requirements for Board membership, shall be set forth in the bylaws of the corporation. By election to the Board, a director shall also be a member of the corporation.

Article 4.1 of the bylaws of Tampa Music Society reads: The Corporation shall designate a Board of Directors who shall initially be appointed the incorporator and founder to serve. Directors will then be elected to serve on the Board by a simple majority of the Directors; so long a quorum has been met. Directors will serve until such Director's death, resignation, or removal as provided by these bylaws.

Article 4.10 of the bylaws of Tampa Music Society reads: Vacancy. Any vacancy occurring in the Board of Directors shall be filled by majority vote of the remaining Directors, though less than a quorum. Each person so elected shall serve until the duration of the unexpired term, or until the next annual meeting. The incorporating Board of Directors shall serve initial terms of three years unless otherwise asked and agreed upon by a majority of the Board of Directors.

Section 5.3—Initial Directors of the Corporation

The initial Board of Directors shall consist of the following Directors:

Article 6.

Officers of the Corporation

Section 6.1—*Election of Officers*

The manner of election of officers and their terms shall be set forth in the bylaws. (See Section 5.2)

Section 6.2—Number of Officers

The corporation shall initially have two officers, a president and treasurer. The Board may, by resolution, add additional officers, as it deems appropriate.

Section 6.3—Initial Officers of the Corporation

The initial officers of the corporation shall be:

President—Nelson Rodriguez-Parada Vice-President—Roger Scruggs Treasurer—Chrissy Russell Secretary—Adrienne Wills

Article 7.

Bylaws of the Corporation

The Board shall adopt the initial bylaws of the corporation by majority vote of the Directors present and voting at a meeting called for that purpose provided a quorum is present. Thereafter, any amendment, modification, rescission or creation of a bylaw shall require two-thirds (2/3) majority vote of the Directors in favor of change at any regular meeting of the Board or at any special meeting called for that purpose. The procedure for creating, amending, modifying, or rescinding bylaws shall be set forth in the bylaws.

Article 8.

Amendment of the Articles of Incorporation

These Articles of Incorporation may be amended, modified, or rescinded by a two-thirds (2/3) majority vote of the entire Board of Directors. The vote for the amendment, modification, or rescission of these Articles of Incorporation may take place at any regular meeting of the Board of Directors or at any special meeting called for that purpose.

Article 9.

Principal Office Address

The initial principal office address of the corporation is located at 2512 Oleander Lakes Drive, Brandon, Florida 33511. The corporation's mailing address is located at the same address.

Article 10.

Initial Registered Office and Agent of the Corporation

The initial registered office of the corporation is located at 2512 Oleander Lakes Drive, Brandon, Florida 33511. Nelson Rodriguez-Parada is the initial registered agent of the corporation at that address.

Article 11.

Incorporator of the Organization

The incorporator is Nelson Rodriguez-Parada, 2512 Oleander Lakes Drive, Brandon, Florida 33511.
