

ARTICLES OF INCORPORATION OF

We, the undersigned, hereby apply for the purpose of becoming a nonprofit corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges, duties, and immunities of a corporation not for profit, under and pursuant to these Articles of Incorporation.

ARTICLE I

That the name of this ${\bf non}$ profit corporation is: THE 3^{RD} STREET CHARITY, INC.

ARTICLE II
