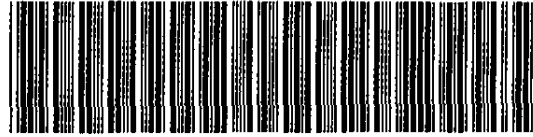



We, the undersigned, hereby apply for the purpose of becoming a **nonprofit** corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges, duties, and immunities of a corporation **not** for profit, under and pursuant to these Articles of Incorporation.

**ARTICLE I**

That the name of this **nonprofit** corporation is: THE 3<sup>RD</sup> STREET CHARITY, INC.

**ARTICLE II**

That the general nature of the Charity group is to transact and carry on are that the non-profit corporation may engage in any activity or business under the laws of the United States and of this State and the specific purpose is to allow volunteers to come forward and participate in the daily operations and joining in helping to raise funds for the needy and deserving individuals based on financial needs; and to allow fund raising efforts; and to encourage various agencies in lending man power, and to insure the success in the continuation of providing guidance and financial need to those selected to receive the donations. The primary condition of selections is based on financial need.

**ARTICLE III**

This **nonprofit** corporation shall have perpetual existence.

#### ARTICLE IV
