

### **Central Florida Softball Organization, Inc Article of Correction**

Article III should read as follows:

The specific purpose for which this corporation is organized is:

3.01 To operate and engage exclusively in exempt purposes within the meaning of 501(c)(3) of the Internal Revenue Code or the corresponding section of any future tax code.

3.02 To be a nonprofit organization dedicated to the promotion of amateur sports competition, specifically softball, for all persons regardless of age, sexual orientation or preference, with special emphasis on the participation of member of the Gay community; and to otherwise foster national and international sports competition by planning, promoting and carrying out amateur sports competition.

Article IX should be added as follows:

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose.
