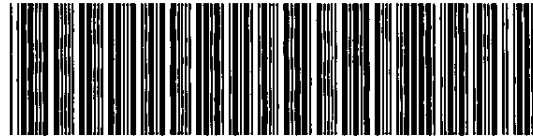

Add Article VI:


