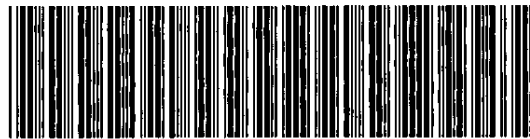

**ARTICLES OF INCORPORATION  
FOR  
YOUTH OUTREACH UMBRELLA, INC.**

**ARTICLE I- NAME**

The name of this Corporation is YOUTH OUTREACH UMBRELLA, INC.

**ARTICLE II-PRINCIPAL OFFICE**

The principal place of business address of this Corporation shall be:

The duration of the Corporation shall be perpetual.

**ARTICLE III- NATURE OF BUSINESS**

The general purpose or purposes is/are to work with the less fortunate in the community; assisting under privileged children with food and clothing and the basic necessities, providing guidance and counseling, mentoring, consulting and all other lawful business activity for which the Corporation may be incorporated under Chapter 607 of the Florida Statutes.

- A. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501© (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- B. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of 501©(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, State, or local government for a public purpose. Any such assets not so disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

**ARTICLE IV – MANNER OF ELECTION OF DIRECTORS**

The manner in which the Directors are qualified, elected or appointed is as follows: each year at its General Annual Meeting, the members of the Corporation shall elect a Board of Director to serve for the ensuing year as provided for in the by-laws.

## **ARTICLE IX- BOARD OF DIRECTORS**

### **Section I.**

**This Corporation shall be operated and governed by a Board of Directors.**

**The by-laws may provide another name for the Board of Directors, and otherwise provide for the extent and limit of their powers, duties and privilege and, further, shall provide the manner of appointment, qualification or election and other matters relating thereto, subject to restrictions herein, including:**

- a. The number of Directors may be provided for in the by-laws but shall at times not be less than three (3).**
- b. The Board of Directors have power to make, alter, or rescind all such by-laws and regulations to rule the business of the Corporation as will not be inconsistent with these Articles, or of the laws of the State of Florida. All changes just be ratified by two thirds (2/3) of the membership of the Corporation.**
