Articles of Incorporation of

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: This is a Christ Centered 12 Step Program. The purpose of this ministry is to gather strength through Jesus Christ our Higher Power, understanding through fellowship, and prayers for our personal journey to the healing of our hearts and renewing of our minds. We practice Christ-Centered 12 Steps which we believe are practical applications of Biblical principles.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.
