## Articles of Incorporation

### Article I      Name

The name of this corporation shall be: "education: access, Inc."

### Article II      Principal Office

### Article III      Purpose

education: access, Inc. is a non-profit corporation and shall operate exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

The purpose of education: access, Inc. is to develop, evaluate, and provide financial support for educational initiatives and programs to increase literacy and educational levels for students in rural and undeveloped areas around the world. We have a few central focuses:

1. Supporting the planning and construction of basic facilities and the purchase of supplies
2. Introducing innovative educational training and extracurricular programs to nurture critical thinking and analytical skills among local children
3. Providing financial assistance through scholarship/sponsorship programs to increase access to primary, secondary, and tertiary education

Both relate to our commitment to providing a holistic educational experience and a strong community support structure.

### Article IV      Non-Profit Nature

education: access, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of education: access, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. The property of this corporation is irrevocably dedicated to the purpose stated in Article III, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual. No substantial part of the activities of education: access, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt

from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article V      Manner of Election**

The control and management of the affairs of education: access, Inc. and of the disposition of its funds and property shall be solely vested in a Board of Directors. The number of directors, the term of office, and the manner of selection and election shall be determined according to the By-Laws of education: access, Inc. as amended from time to time.

**Article VI      Dissolution of Assets Provision**

Upon the dissolution of education: access, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
