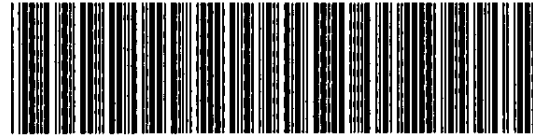

Article 3 — Purpose:

The purpose of this corporation is to:

- A3-Sec.1 — This Alliance Ministry shall hold as it imperative duty to make known the Gospel of Jesus Christ throughout the entire earth and world, and to teach and preach the Word of God to the end, to those who believe, and maybe conformed to the image of Jesus Christ.**
- A3-Sec.2 — To adopt, live by and minister the Word of God in it entirety as canonized and derived from the original Hebrew and Greek languages as constitution by laws of Kingdom Alliance Ministries Worldwide, Inc.**
- A3-Sec.3 — This Ministry shall endeavor to exemplify the love of God through charitable concerns for the help of it members, partners and it's fellow man. We will work with all people accepting God grace regardless of race, social position or fellowship. We will develop and carry out programs to help the poor, underprivileged, afflicted, widowers, imprisoned and aged communities.**
- A3-Sec.4 — To maintain this organization inherent rights to sovereignty in the conduct of life in accordance with the Articles of Incorporation and voluntary enter into a cooperative fellowship with the Body of Christ.**
- A3-Sec.5 — To provide basic New Testament discipleship to all: To bring pleasure to the Father by the purity of our heart and attitude. To infiltration our daily lives with the Wisdom of God through the Lord Jesus Christ.**
- A3-Sec.6 — To perform the sacrament of the church which include, but not limited to: The baptism of believers in water by immersions, the celebration of the Lord Supper, to anointing of leaders for service to God and the sick with the laying on of hands: and conduct weddings and funerals services.** History.—s. 1, Nov. 2, 1829; s. 2, ch. 1127, 1861; RS 2056; GS 2575; RGS 3934; CGL 5853; s. 1, ch. 28104, 1953; s. 1, ch. 74-372; s. 1, ch. 78-15; s. 34, ch. 95-401
- A3-Sec.7 — To ordain people who has shown to be Gifted Leaders in ministries, to maintain and establish other churches, institutions and establishments to help meet the communities needs. Such institutions shall be of a religion, charitable or educational purpose as described in section 501 (c)(3) of the Internal Revenue code of 1954, or any corresponding provision of any future United States Revenue Law. They shall include but are not limited to: Bible schools, Bible Colleges, Christian Day Care Centers, Christian Schools, Homes for the Aged, indigent, widows, orphans, alcoholics and drugs addictions or other persons in need of the necessary provisions of life.** Florida Statutes — Title XLIII: Domestic Relations — Chapter 741: Marriage; Domestic Violence
- A3-Sec.8 — Receive tithes, offerings, gifts, bequests, donations and other income and to solicit funds and raise money to fulfill the purpose of this corporation. To borrow money, issue bond debentures, notes, or other obligations, secure moneys so borrow or in payment for property, or any of the purposes of this corporation.**

The foregoing shall not be construed to limit the purpose of this corporation or in any way inhabit this corporation from doing or undertaking any other purpose lawfully authorized in Section 617.0302, Florida Statutes or other applicable law.

Article 4 — Manner of Election of Directors

The manner in which the directors are elected or appointed:

The directors of this Corporation will be elected by members at its annual meeting in accordance with the By-Laws of this Corporation.

The affairs of the Ministry, both spiritual and secular, shall be directed by a Board of Managers which shall be referred to as the Board of Trustees. The minimum number of Board of Trustees Members may be increased in accordance with the needs of the Ministry as determined from time to time by the governing Board of Trustees. The Board Members themselves must be members of the church .

The Board of Trustees may appoint a council of Advisors, the number of which shall be determined by the Board of Trustees, which shall serve in the capacity of spiritual and secular advisors. Such council of Advisors shall have powers only as determined by the Board of Trustees.

The Board of Trustees shall appoint such Board Members, in addition to any Council Members, as may be necessary to properly minister to the membership and carry out the purposes for which this Ministry is organized. Board and Council Members so appointed must possess all of the qualifications as set

forth by the board of Trustees: once appointed shall serve as long as they remain members of this Organization, unless removed as set forth hereinafter.

The initial governing Board of Trustee, shall be deemed to have been set in office as of the time these Articles are approved and filed by the Secretary of the State of Florida. Thereafter, in the event of a vacancy on the board of Trustee, whether caused by resignation, removal, death, or expansion of the Board, the ruling board then serving shall suggest to the membership of the organization the name of a member deemed to be qualified to serve. If there be no unresolved objection the governing Board Members shall suggest another name, and the process continue until the vacancy or vacancies shall have been filled.
