Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: This corporation will hold various charitable events to raise funds from the private and public. Also will organize various religious events to spread the principle of all religions worldwide and will try to establish one contact office locally in various countries. The funds raised will be used for the good cause of humanitarian service, animal protection, educational help to students, help whatever way possible for elder communities as well as orphans and blind and deaf persons. Also keep up with state and federal regulations of the each country this non-profit corporation is going to help in the future including easy access to transfer the funds from one country to other needy countries.
