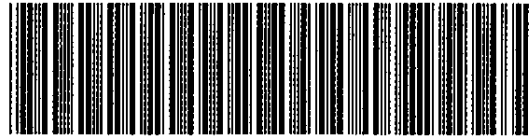



In compliance with the requirements of F.S. Chapter 617 (Not for Profit), the undersigned hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a non-profit business corporation.

ARTICLE I - NAME

The name of the Corporation is: CAR CARE MINISTRY, INC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

This organization is a nonprofit corporation and is not organized for the private gain of any person. It is organized for charitable purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, which will provide automotive repairs and service to those in the community who cannot afford such repairs and service and to provide transportation solutions for poor, distressed, or underprivileged people who would otherwise lose their job without reliable transportation.




