ARTICLE III PURPOSE

This Corporation is organized exclusively for charitable, educational and recreational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding Section of the future Federal Tax Code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to, its participants, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of the corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign of behalf of, or in opposition to, any candidate for public office. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding Section of any future Federal Tax Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organizations, as said court shall determine, which are organized for such purpose.

The focus of Saving God's Creatures Animal Rescue is to promote the welfare and safety of all animals, especially stray and abandoned pets through a combination of rescue through adoption/foster programs, pro-active vetting including spay/neuter programs with the assistance of rescue groups, no-kill shelters, public and private agencies and compassionate volunteers. Focus will be on those most at risk such as abandoned, neglected and senior animals who have been surrendered to high-kill shelters by their owners who no longer can or want to care for their aging pets, as well as the helpless and abandoned animals who walk the streets with no place to call home and having no food or shelter available to them. It is our mission to rescue these abandoned animals as it is imperative in order to save them from a life of suffering, disease and impending death.

ARTICLE IV MANNER OF ELECTION The Corporation shall have no fewer than three and no more than fifteen Directors and collectively they should be known as the Board of Directors. Directors shall be elected by the majority vote of the Board.
