The Ministry will during our Annual Board Meeting sow a love offering of \$100.00 to each member of the board for their voluntary services to our continued Spiritual growth and development of this God sanctioned ministry. Article VIII added. The Pastor's Demise in the event of the Pastor's Demise the Board of Directors shall collectively govern the affairs of the church until the next Annual Meeting. The order of leadership shall be Vice-President, Spiritual Advisor, Educational Advisor, Secretary, Treasurer/Trustee. During the annual session the Board shall prayerfully consider a Pastor after God's heart. This servant be he/she shall not be a novice (one without pastoral experience) but one that has proved himself acceptable unto the Lord, with recommendations from his previous affiliations. The board may establish any additional requirements as lead by God. May God bless them to make a prayerful and God ordained choice.
