Pursuant to Florida Statute §617, the undersigned, acting as Incorporator, does hereby submit these Articles of Incorporation for the purpose of forming a not for profit corporation.

ARTICLE 1  
Name

The name of the not for profit corporation is: Greyed A Greyhound Assistance and Placement Services, Inc.

ARTICLE 2  
Principle Office/Mailing Address

The Principle office of the corporation shall be: 13386 La Mirada Circle, Wellington Florida, 33414, and the mailing address shall be the same.

ARTICLE 3  
Purpose

This corporation is a not for profit corporation organized to provide financial assistance, within the continental United States of America, to owners and owners' agents of racing Greyhounds or qualified Greyhound adoption groups to help offset costs and ensure proper veterinary care of injured or sick Greyhound dogs who would otherwise not be assisted due to limited resources. It will offer assistance facilitating transportation of retired racing Greyhound dogs to qualified Greyhound adoption groups or hold Greyhounds for later placement into qualified adoptive homes.

This corporation is organized exclusively for charitable and educational purposes under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities, or exercise any powers not in furtherance of section 501(c) (3) purposes.

ARTICLE 4  
Manner of Election

The manner in which the Board of Directors are elected and appointed shall be as provided for in the bylaws.

#### ARTICLE 6

##### Effective Date

The effective date for this corporation shall be April 28, 2014.

#### ARTICLE 7

##### Prohibited Activities

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 11. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

#### ARTICLE 8

##### Distributions Upon Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
