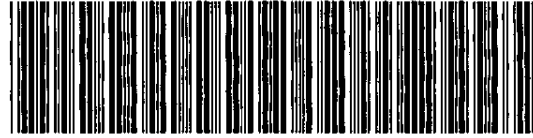

Article III is amended to read: The specific purpose of this organization is to educate people on making positive decisions and motivate them to make good choices in life through a faith based platform of talks and events. This organization is organized exclusively for religious, charitable, scientific, literary and educational within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. Notwithstanding any other provisions of these articles, this organization shall not carry on by an organization exempt from the Federal Income Tax Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United State Revenue Law.

2. Article VIII is added to read: Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal, State or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
