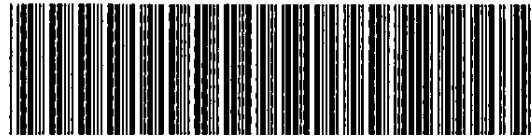

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Inner Voice Productions Inc.

ARTICLE III PURPOSE

The purpose for which this corporation is organized is: to engage in any lawful act or act or activity for which corporations may be organized under the Florida Corporations Not For Profit Statutes.

The corporation is organized and shall be operated exclusively for the religious, educational, charitable, and literary purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1954, and regulations promulgated thereunder.

The corporation is especially organized to execute the purposes enumerated in this Article. Said purposes shall be executed according to the tenets and practices revealed by recognized spiritual teachers coming in disciple succession of the Madhva Gaudiya Sampradaya which culminates in the teachings and personal example of His Divine Grace A.C. Bhaktivendanta Swami Prabhupada, the Founder-Acharya of the International Society for Krishna Consciousness (ISKCON), a recognized religious denomination, also known as the Hare Krishna Movement:

Purposes of Corporation:

1. To create and distribute documentary film productions, visual communication and publications to the general public and within ISKCON in order to strengthen the Society and to attract new members. Such projects/publications shall achieve this goal in the following means:
 - (a) Record/Present the worldwide works of Hare Krishna devotees and supporters to inject spiritual consciousness in society at large.
 - (b) Increase awareness of the significance and purpose of Krishna Consciousness.
 - (c) Stimulate and encourage the public to question the purpose of life/consciousness.
 - (d) Provide access to historic spiritual resources.
 - (e) Demonstrate how ISKCON, the Hare Krishna Movement, benefits individuals and society by providing practical solutions to the problems of today's world.

- (f) Encourage study of the culture and philosophy of Krishna Consciousness as presented in the literature and films of His Divine Grace A.C. Bhaktivedanta Swami Prabhupada.
2. To preserve and promote cultural and historical information collected by the corporation.
3. To receive, administer and distribute funds, and to do all other things necessary and proper in furtherance of the above stated purposes.

ARTICLE IV MEMBERS

The Corporation shall have no members. However, any action which would otherwise, under law or the provisions of the Articles of the Incorporation or Bylaws of the Corporation, require approval by a majority of all member or approval by a majority of all member s or approval by members, shall require the approval of the Board of Directors.

Furthermore, all rights, which would otherwise vest in the members under law, the Articles of Incorporation or the Bylaws of the Corporation, shall vest in the Directors of the Corporation.

ARTICLE V MANNER OF ELECTION

The manner of selection of officers and directors of the Corporation and any all rules and regulations as shall be deemed necessary for carrying out the purposes of the Corporation shall be stated in the Bylaws of the Corporation.

ARTICLE VI BYLAWS

The Bylaws of the Corporation shall be made, altered or rescinded by the Board of Directors.

ARTICLE VII DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon the dissolution of the Corporation, the Board of Directors of the Corporation shall, after paying or making provision for the payment of all the liabilities of the Corporations, dispose of all the assets of the Corporation exclusively to other educational institutes, communications offices or integral agencies of the International Society for Krishna Consciousness in accord with the educational and religious purposes of the Corporation, or for one or more other exempt purposes within the meaning of Section (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code as determined by the Directors.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the Corporation is located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

No part of the net earning of the corporation shall incur to the benefit of, or be distributed to its trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

No substantial part of the activities of the corporation shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (2) by a corporations, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
