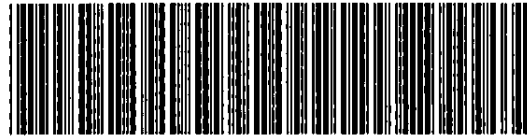

ARTICLE III – PURPOSE

The purpose for which the corporation is organized is:

- (a) SoFlo Volleyball Academy Inc is organized exclusively for charitable and educational purposes as specified under Section 501(c)(3) of the Internal Revenue Code to educate the youth about sports, including but not limited to, the sport of volleyball in a positive way; to promote sports programs and activities for the youth; to provide facilities and educational services needed to facilitate such opportunities; to support youth sports teams and competitions; to serve as role models and to mentor the youth involved in sports; and to promote healthy, active lifestyles while providing organized opportunities for physical fitness, wellness education and psycho-social empowerment among the youth through sports.
- (b) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its directors, trustees, officers, or other private persons except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes as stated in (a) above.

- (c) This corporation will not participate in any political campaigns nor influence legislation.

ARTICLE IV – MANNER OF ELECTION

The manner in which the directors are elected or appointed is:

Directors of the corporation will be elected in the manner specified in the corporation's Bylaws. The number of members on the Board of Directors may be increased or decreased from time to time by a vote of the Board of Directors in accordance with the Bylaws of the corporation but at no time will the corporation have less than 3 Directors. These Articles of Incorporation do not need to be amended each time new Directors are appointed.
