Articles of Organizations of East Coast Islamic Center is Amended adding Article XIX
as follows:

Article XIX - Distribution of Asset Upon Dissolution:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt
purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or
corresponding section of any future federal tax code, or shall be distributed to the federal
government, or to a state or local government, for a public purpose. Any such assets not
disposed of shall be disposed of by a court of competent jurisdiction in the county in which the
principal office of the organization or organization is then located, exclusively for such purposes
or to such organization or organizations, as said Court shall determine, which are organized and
operated exclusively for such purposes. The ARTICLE XIX further precedes over any
conflicting statements stated in the previously approved articles of incorporation for East Coast Islamic Center Inc.

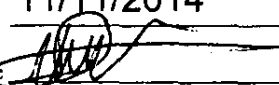
