# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF EDIBLE EDUCATION EXPERIENCE, INC.



Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned Florida not for profit corporation adopts the following amendments to its Articles of Incorporation:

# ARTICLE I - NAME

The name of the corporation is Edible Education Experience, Inc. (the "Corporation"), Florida Document Number N14000004856.

# ARTICLE II - TEXT OF AMENDMENTS

A. Article 9 shall be replaced in its entirety with the following:

### Article 9.

Upon the dissolution of the Corporation, after the payment or provision for the payment of all of the liabilities of the Corporation, all of the assets of the Corporation shall be distributed to Florida Conference Association of Seventhday Adventists, a Florida not for profit corporation that is tax-exempt pursuant to Section 501(c)(3) of the Internal Revenue Code, for the benefit of Orlando Junior Academy, a division of the Florida Conference of Seventh-day Adventists; provided, that in the event that Florida Conference Association of Seventh-day Adventists is not a charitable organization within the meaning of Section 501(c)(3) at the time of such distribution, then all of the assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Code Section 501(c)(3), or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

B. A new Article 11 shall be added to the Articles of Incorporation as follows:

### Article 11.

Any amendment to these Articles of Incorporation must be approved by a majority vote of the directors then in office; provided, however, that any amendment to Article 9 must also be approved by the Florida Conference Association of Seventh-day Adventists.
