**ARTICLES OF INCORPORATION  
OF  
THE MISSION INDIA, INC.  
A FLORIDA NOT FOR PROFIT CORPORATION**

In compliance with the requirements of Florida Statutes, Chapter 617, the undersigned incorporator has executed, adopted and caused to be delivered for filing these Articles of Incorporation for the purpose of forming a corporation not for profit and does hereby certify:

**ARTICLE I  
NAME**

The name of this corporation shall be: The Mission India, Inc.

**ARTICLE II  
DURATION**

The duration of the Corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the Articles of Incorporation by the Department of State of the State of Florida.

**ARTICLE III  
PURPOSE**

The purpose of the Corporation shall be exclusively charitable in nature, to-wit: To engage exclusively in activities for charitable or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code), and within these restrictions, to receive contributions and use them for charitable or educational purposes including but not limited to providing support for Christian mission activities. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code), or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code).

**ARTICLE IV  
PRINCIPAL OFFICE**

**ARTICLE V**  
**REGISTERED OFFICE AND AGENT**

NRAI Services, Inc., 1200 South Pine Island Road, Plantation, FL 33324, is hereby appointed the initial registered agent of the Corporation and the registered office shall be at said address.

**ARTICLE VI**  
**DISSOLUTION OF THE CORPORATION**

Upon the dissolution of the Corporation the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable or educational purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code), as the Board of Directors shall determine.

**ARTICLE VII**  
**MEMBERSHIP**

Membership in the Corporation shall be as provided in the Bylaws of the Corporation.

**ARTICLE VIII**  
**BOARD OF DIRECTORS**

The number of Directors constituting the initial Board of Directors is three (3) and the name and address of each person who is to serve as a member thereof are as follows:

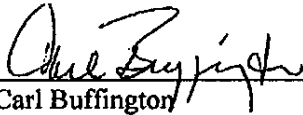

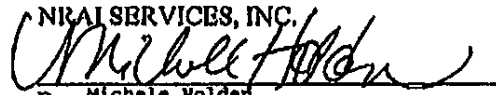
