
On January 17, 2014, we filed to incorporate two companies. Hazley Productions, Inc. is a profit corporation. Hazley Music School, Inc. is a non-profit corporation. It was unfortunate that both were filed on the same *for profit* form. We contacted your office and were told to file an **amendment**, which we did *and* sent the requested additional fee.

We received your letter, dated April 23, 2014, stating we filed the amendment on the wrong form and the correct *for profit* form was attached for our convenience. We again contacted your office for instruction to clear up the conflicting information. This time we spoke with an employee who had been with your office for 33 years, so hopefully we will get this right with her instruction.

HAZLEY MUSIC SCHOOL, INC., P14000008620, was dissolved on May 13, 2014. The confirmation number is 200260172422. **We are releasing the name, Hazley Music School, Inc., for the new corporation. We are not planning on revoking the dissolution of Hazley Music School, Inc.**

The additional fee that we sent, **\$43.75**, is being held per letter from Carolyn Lewis, Regulatory Specialist II. During our last telephone conversation with your office, we were asked to send in the difference for the new filing. The new filing fee is **\$78.75**. We have enclosed the **\$35.00** balance, as directed.
