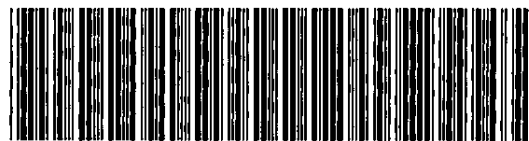

ARTICLE I – NAME

ARTICLE VIII- DISSOLUTION

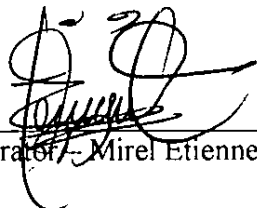
