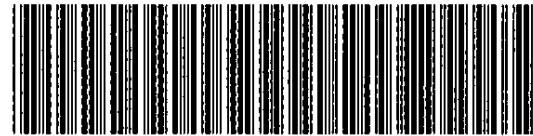

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator pursuant to Chapter 617 Florida Statutes, forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of this corporation (church) is: PROMISE LAND CHRISTIAN FELLOWSHIP INC.

ARTICLE II

The period of duration of this corporation is perpetual unless dissolved according to law. The effective date of these articles shall be May 21, 2014.

ARTICLE III

The purpose for which the corporation is organized is to further the Gospel of the Lord Jesus Christ and to engage in any lawful act of activity for which corporations may be organized under the Florida Non-Profit Corporation Law including the ordination of ministers of the Gospel.

This church was founded to provide all religious purposes of a church and educational facility within the meaning of IRC Section 501 (C) (3) and as amended for the sole purpose of developing and educating the Body of Christ Jesus.

No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including publishing or distribution of statements) on behalf of any candidate for public office.

ARTICLE V

In the event of dissolution of the corporation, no part of the corporation's earnings or assets shall inure to the benefit of any of its members; the residual assets of the corporation shall be distributed to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986, or corresponding sections of any prior or future law, or to the federal, state or local government for exclusive public purpose.

ARTICLE VI

The manner in which directors are elected or appointed is as provided for in the bylaws.

ARTICLE VII

Directors shall be elected in the manner set out in the Bylaws of the corporation. The number constituting the initial Board of Directors of the corporation is three (3) and names and addresses of the persons who are to serve initially are:

Article VIII

This corporation is organized on a non-stock basis.

ARTICLE IX

The property of the Corporation is irrevocably dedicated to nonprofit religious purposes. No part of the net earnings of the Corporation shall inure to the benefit of its directors, officers, or to any other individual, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments in the furtherance of the nonprofit religious purposes of the Corporation.

ARTICLE X

In furtherance of its religious nonprofit tax-exempt purposes, the Corporation shall have the following powers and authority:

- 1) To do all acts, perform all functions and carry on all activities permitted by the nonprofit corporation (and regular corporations not prohibited by nonprofit religious corporations) of the State of Florida (or any other state in which the Corporation is qualified to act).
- 2) To use all forms of media including but not limited to print, television, radio, the World Wide Web and those discovered or not yet discovered.

ARTICLE XI


The liability of a volunteer Trustee of the church shall be limited, eliminated, or assumed to the extent as is authorized under the relevant laws of the state in which this church is formed, except to the extent such limitation, elimination, or assumption of liability is inconsistent with the status of the church as an organization described in Section 501(c) (3) of the Code or results in the imposition of tax under Section 4958 of the Code. No amendment or repeal of this Article shall apply to or have any effect on the liability or alleged liability of any member of the Board of Trustees or officer of this church for or with respect to any acts or omissions of such trustee occurring prior to the effective date of any such amendment or repeal.


