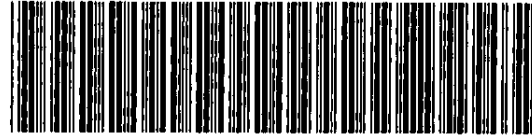

ARTICLES OF INCORPORATION

Incompliance with Chapter 617, F.S., (Non-Profit)

Article I. Name

- Like the Days of Noah Ministry Inc.

Article II. Address

Article III. Specific Purpose

- This corporation/ministry shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in compliance with sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Section 1: Introduction

- This corporation/ministry was organized exclusively for the purpose of providing religious, charitable, and educational services to the community. In accordance with the Holy Bible, we must be fully equipped with the armor of Yahweh/Elohim, overflowing with the fruit of the Holy Spirit of Yahweh/Elohim, used with the gifts of the Holy Spirit of Yahweh/Elohim, preach the Good News of the Gospel of the Lord Yeshua HaMashiach, and make disciples. This corporation/ministry is solely based on the Doctrine of the Son of Yahweh/Elohim, Yeshua HaMashiach.

 - This corporation/ministry, Like the Days of Noah Ministry Inc., is the sole controlling entity of the assembly.
- Evangelism Ministry
 - The purpose of the evangelism ministry is to ensure that religious, charitable, and educational services are provided to the public, in accordance with its job description, by keeping critical incident logs and conducting performance evaluations on a regular basis.
 - The evangelism ministry focuses on preaching the Good News of the Gospel of the Lord Yeshua HaMashiach.
 - This corporation/ministry, Like the Days of Noah Ministry Inc., is the sole controlling entity of the evangelism ministry.
- Praise and Worship Program
 - The purpose of the praise and worship program is to ensure that religious, charitable, and educational services are provided to the public, in accordance with its job description, by keeping critical incident logs and conducting performance evaluations on a regular basis.
 - The praise and worship program focuses on praising and worshiping Yahweh/Elohim and the Lord Yeshua HaMashiach.
 - This corporation/ministry, Like the Days of Noah Ministry Inc., is the sole controlling entity of the praise and worship program.
- Community Outreach Program (C.O.P.)
 - The purpose of the community outreach program is to ensure that religious, charitable, and educational services are provided to the public, in accordance with its job description, by keeping critical incident logs and conducting performance evaluations on a regular basis.

- The community outreach program focuses on finding missing people and most wanted criminals.
- This corporation/ministry, Like the Days of Noah Ministry Inc., is the sole controlling entity of the community outreach program.

Article IX. Dissolution Clause

- In compliance with section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, upon dissolution of this corporation/ministry any and all assets will be completely distributed, **by random assignment**, to nonprofit charitable organizations in the community.

Article X. Net Earnings

- In accordance with the purposes set forth in Article III herein, and in accordance with section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, this corporation/ministry shall not distribute any net earnings to any Board of Directors/Officers or private persons, except reasonable compensation for services rendered.

Article XI. Conflict of Interest Clause

- This corporation/ministry does not consider it a conflict of interest to be an active member of the assembly, evangelism ministry, praise, and worship program and Community Outreach Programs simultaneously, because they have a vested interest in all due to the fact that this corporation/ministry is family owned and operated, and all have specific organizational job descriptions which accounts for any conflict of interest. Furthermore, this corporation/ministry is organized in such a way as to account for a conflict of interest which ensures, to the best of its ability, that there is no potential to undermine self-interest verses professional interest.

Article XII. Statement of Faith

This corporation/ministry believes in the following:

- *This corporation/ministry uses the Hebrew-Greek Key Study Bible, New American Standard Bible, 1960, 1962, 1963, 1968, 1971, 1972, 1973, 1975, 1977, 1984, and 1990, Compiled and Edited by Spiros Zodhiates, Th.D., by The Lockman Foundation. This is the Holy Bible referred to herein.*
- *The Doctrine of the Lord Yeshua HaMashiach found in the Holy Bible, therefore, we live according to the Grace of the New Testament, and not according to the Law of the Old Testament.*

Section 1: Godhead (Holy Bible, Genesis1:26-28; Colossians 2:9)

- **Godhead**

- The Godhead is the unity of the Father, Yahweh/Elohim, the Son, Yeshua HaMashiach, and the Holy Spirit. They are three persons in one Godhead (Holy Bible, Matthew 28:19).
 - Father, Yahweh/Elohim (Hebrew)
 - God has a many names, but the more commonly used names in the Holy Bible are Yahweh and Elohim. Yahweh (comes from YHVH (pronounced YHWH and is without vowels) is "LORD", and Elohim is "God". He is the Father and first person of the three persons of the Godhead. This corporation/ministry has chosen to use the original Hebrew name not the English translation out of respect for Yahweh/Elohim (Holy Bible, Genesis 1:1; Exodus 6:1-8)
 - Son, Yeshua HaMashiach (Hebrew)
 - Yeshua HaMashiach has many names as well, but, the more commonly used name in the Holy Bible is Yeshua. It is known as Jesus in English. There are two predominate theories about the translation of the name Jesus. The first refers to the name Yeshua being mixed with the pagan Greek word/god, Zeus to create the name "J'Zeus". The second refers to the name Yeshua being translated from Hebrew into a non-pagan Greek word, "Yesous". Regardless, any moral believer using the name of Jesus in English would use it assuming it were a non-pagan translation in English, and would not be held accountable by Yahweh/Elohim for using it. Nevertheless, this corporation/ministry has chosen to use the original Hebrew name not the English translation, out of respect for Yeshua HaMashiach (Jesus the Messiah). He is the Son of Yahweh/Elohim and the second person of the three persons of the Godhead. He is the Savior of the World. He is the only person an individual can go through to get to the Father, Yahweh/Elohim. He dwells within the believer (Holy Bible, John 3:16).
 - Holy Spirit
 - The Holy Spirit has a number of names and symbols, but, the more commonly used name in the Holy Bible is the Holy Spirit of Yahweh/Elohim. He is the power, authority, and works and third person of the three persons of the Godhead. He washes the sinner with the Blood of Yeshua HaMashiach, dwells within the believer, arms the believer with the Amor of Yahweh/Elohim, and uses the believer with the gifts of Yahweh/Elohim, which is the demonstration of the power of Yahweh/Elohim (Holy Bible, John 15:26).

Section 2: Salvation in Yeshua HaMashiach (Holy Bible, John 3:3-21)

- **Physical Act of Asking for Salvation**

- All have all sinned and come short of the glory of Yahweh/Elohim, therefore, it takes an outward physical act of spoken prayer, by faith in Yeshua HaMashiach, to repent of all sin and ask for salvation, which represents the desire of the individual to kill the sinful flesh and live a holy life by the Holy Spirit of Yahweh/Elohim.
- **Spiritual Act of Receiving Salvation**
 - After the outward physical act of spoken prayer for salvation, the Holy Spirit of Yahweh/Elohim washes the sinner's sins away with the blood of Yeshua HaMashiach (which was shed on the cross by the crown of thorns, the whip, and by being pierced with the nails and the spear) and the sins are nailed to the cross forever (not in the depths of the sea in accordance with the law of the Old Testament). Yeshua HaMashiach paid the debt of sin so that humanity could live an everlasting life in him free from sin.

Section 3: *Water Baptism of Yeshua HaMashiach (Holy Bible, Mark 16:15-18)*

- **Symbolic Act of Washing of Water by the "Word"**
 - An outward physical act of baptism which represents the desire of the individual to kill the sinful flesh and live a holy life by the Holy Spirit of Yahweh/Elohim. The act of immersing the body in water is a symbol of the death of Yeshua HaMashiach, and rising out of the immersion of water is a symbol of the resurrection of Yeshua HaMashiach and a holy life by the Holy Spirit of Yahweh/Elohim in Yeshua HaMashiach.
- **Spiritual Act of Washing of Water by the Word**
 - An inward spiritual act of baptism which represents the desire of the individual to kill the sinful flesh and live by the Holy Spirit of Yahweh/Elohim. The water that was shed when Yeshua HaMashiach was pierced with the spear while he was on the cross, is the water that baptizes the individual through the washing of water by the Word/Yeshua HaMaashiach. It is this water that an individual feels as a river of living water welling up out of the belly of oneself.

Section 4: *Holy Spirit Baptism of Yahweh/Elohim (Holy Bible, Acts 2:1-8)*

- After salvation comes the Holy Spirit baptism. The believer is filled overflowing with the Holy Spirit and power of Yahweh/Elohim. The believer is equipped with the full armor of Yahweh/Elohim. The believer is used by Yahweh/Elohim with the gifts of the Spirit of Yahweh/Elohim for the building up of the body of Yeshua HaMashiach. However, all of this is only possible by first pursuing Love/Yahweh/Elohim through Yeshua Hamashiach.

Section 5: *Sanctification (Holy Bible, Romans 12:1-2)*


- **Process of Sanctification**

- The spiritual service of worshiping Yahweh/Elohim (which kills the flesh/sin), instead of the fleshly act of worshiping satan, is to present our bodies daily as a living and holy sacrifice, acceptable to Yahweh/Elohim.
- Believers must give their undivided attention to Yahweh/Elohim in the Spirit and Truth of Yahweh/Elohim daily. The following three components are necessary for the process of sanctification and in order to build a relationship with Yahweh/Elohim through Yeshua HaMashiach, and it is necessary to do all three simultaneously (Holy Bible, Matthew 7:7-12):
 - Fasting = Knock and Door Will be Opened. This means to come into Yahweh/Elohim's presence to receive spiritual food and kill the flesh.
 - Studying the Holy Bible = Seek and You Will Find. This means to study the Holy Bible/Word/Yeshua HaMashiach. The believer will receive understanding of Him by spiritually discerning Hiim. Which means that the Holy Spirit will give the believer understanding. Studying the Holy Bible/Word/Yeshua HaMashiach is spiritual food for the believer.
 - Prayer = Ask and You Shall Receive. This means to communicate, by faith, with Yahweh/Elohim in the name of Yeshua HaMashiach. Whatever the believer asks for he/she will receive, in accordance with the will of Yahweh/Elohim. The believer's faith moves the hand of Yahweh/Elohim. Prayer is spiritual food for the believer.
- **Results of Sanctification**
 - The Character of Yeshua HaMashiach is the first result of sanctification (Holy Bible, Ephesians 4:23-27; 5:1-2).
 - Believers are required to pursue Love/Yahweh/Elohim in order to be filled overflowing with the fruit of the Holy Spirit of Yahweh/Elohim (Holy Bible, I Corinthians 13:1; 14:1).
 - The believer obtains the character of Yeshua HaMashiach by being filled with the Holy Spirit and thus being renewed in the Spirit of the mind by the Holy Spirit of Yahweh/Elohim. It is only then that the believer has the mind of Yeshua HaMashiach (Holy Bible, Ephesians 4:23-27; Galatians 5:22-26).
 - The fruit of the Holy Spirit of Yahweh/Elohim is love, joy, peace, patience, kindness, goodness, gentleness, faithfulness, and self-control. If believers have Love they have all of the ingredients of the fruit of the Spirit of Yahweh/Elohim (Holy Bible, Galatians 5:22-26).
 - The believer's character is sinless, humble, meek, quick to listen, slow to talk, and slow to get angry (Holy Bible, James 1:19-22).

- The Armor of Yahweh/Elohim is the second result of sanctification (Holy Bible, Ephesians 6:10-18).
 - Believers are required to put on the full armor of Yahweh/Elohim in order to stand firm against satan, principalities and powers of darkness, and fiery darts.
 - The armor of Yahweh/Elohim is the helmet of salvation, breastplate of righteousness, shield of faith, sword of the Spirit which is the word of Yahweh/Elohim, belt of truth, and to shod the feet with the preparation of the gospel of peace.
- The Gifts of the Holy Spirit of Yahweh/Elohim is the third result of sanctification (Holy Bible, I Corinthians 14:1-19). The Gifts of the Holy Spirit are for the assembly/church/believers of Yeshua HaMashiach, however, this is impossible without faith.
 - Believers are not instructed to pursue the Gifts of the Holy Spirit, but, they are instructed to earnestly desire them. Once the believer pursues Love/Yahweh/Elohim, he/she is able to be used by Yahweh/Elohim with the Gifts of the Holy Spirit, at the will of the Holy Spirit of Yahweh/Elohim (Holy Bible, I Corinthians 14:1).
 - The Gifts of the Holy Spirit are for the equipping of the saints for the work of service to the building up of the body of Yeshua HaMashiach, by edifying, exhorting, and consoling (Holy Bible, I Corinthians 14:1-19; Ephesians 4:11-13).
 - The secrets of the heart are disclosed by the Holy Spirit of Yahweh/Elohim using a believer/*gifted* person, in order for an unbeliever/*ungifted* person to be convicted by all, and called to account by all, so that the unbeliever/*ungifted* person will fall on his or her face and worship Yahweh/Elohim declaring that he is really among the believer/*gifted* person being used with the Gifts of the Holy Spirit (Holy Bible, I Corinthians 14:23-25).
 - The nine Gifts of the Holy Spirit of Yahweh/Elohim are various tongues (angelic tongue which no one understands (unless the Holy Spirit gives the interpretation), and earthly tongue, which are the languages of the world (which utterance is given by the Holy Spirit regardless if the individual knows the language or not), interpretation of tongues, miracles, faith, healing, prophesy, knowledge, wisdom, and discerning/distinguishing spirits (Holy Bible, I Corinthians 12:1-15).


