

## **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is: Lao Arts and Cultural Foundation, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Said organization is dedicated and committed to encouraging, guiding, and mentoring the younger generations of Laotian Americans to pursue and achieve higher education, foster a culture of leadership among young Laotian Americans through active participation in the community, install pride through sponsored athletic events, reach out to senior members to preserve and act as role models of Laotian traditions. Be one voice for a united Florida Laotian American community in regards to local, county, state, and federal government issues, policies and legislation that affect our community as a whole through voting advocacy.


