**Articles of Incorporation
Of
Association of Southern Football Officials, Inc.**

In compliance with Chapter 617, Florida Statutes [Not For Profit Corporations]

Article I – Name of Corporation

The name of this corporation is Association of Southern Football Officials,

Article II – Principal Office

The principal office of the corporation is located at 549 Meadow Ridge Drive,
Tallahassee, Florida 32312.

Article III – Purpose of Corporation

The specific and primary purpose for which this corporation is organized is to provide an organization for football officials to render service in the college, semi-professional, and professional arenas and to encourage and foster high ethical standards and excellence in officiating. This corporation shall have and exercise all rights and powers conferred upon corporations not for profit under the laws of the State of Florida.

Article IV – Membership

The authorized number, qualifications, and manner of admission of members of this corporation, the different classes of membership, if any, the voting and other rights and privileges of members, the liability of members for dues or assessments, and the method of collection thereof, and the termination and transfer of membership shall be as set forth in the bylaws of this corporation.

Article V – Officers

The officers of the corporation shall be President, Vice-President, and Secretary-Treasurer. The qualifications, time, and method of electing, the duties of, the terms of office, and the manner of removing officers shall be as stated in the bylaws.

Article VI – Board of Directors

The powers of this corporation shall be exercised and its affairs conducted by a Board of Directors, which shall be known as the Executive Committee, consisting of the President, Vice-President, and Secretary-Treasurer, and two members at large. The rights and responsibilities of those members of the Board of Directors shall be established as provided in the bylaws of the corporation. The qualifications, time, and method of electing, the terms of office, and the manner of removing the members at large shall be as stated in the bylaws.

Article VII – Registered Agent

Article VIII – Bylaws

Bylaws will be hereafter adopted at the first annual meeting of the corporation and presented to a quorum of members for their vote. Such bylaws may be amended or repealed, in whole or in part, by the members in the manner provided herein. Any amendments to the bylaws shall be binding on all members of this corporation.

Article IX – Amendment of Articles

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the Board of Directors and presented to a quorum of members for their vote. Amendments may be adopted by a vote of two-thirds of a quorum of members of the corporation.

Article X – No Income From Public Events

This corporation will not hold any event in which members of the general public will be invited to participate for a fee.

Article XI – Distribution of Assets Upon Dissolution

In the event of the dissolution of this corporation, or in the event it shall cease to carry out the objects and purpose herein set forth, all the business, property, and assets of the corporation shall go and be distributed to such nonprofit charitable corporation, municipal corporation, or corporations, as may be selected by the Board of Directors of this corporation so that the business properties and assets of this corporation shall then be used for, and devoted to, the purposes of carrying on a purpose similar to this organization. In no way shall any of the assets or property of this corporation, or the proceeds of any of the assets or property, in the event of dissolution, go or be distributed to members, either for the reimbursement of any sums subscribed, donated or contributed by such members, or for any other such purpose, it being the intent in the event of the dissolution of this corporation, or upon its ceasing to carry out the object and purposes herein set forth, that, the property and assets then owned by the corporation shall be devoted to a non-profit purpose qualifying as such under the then provisions of the Internal Revenue Code.

Having been named as Registered Agent to accept service of process for the above-stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as Registered Agent and agree to act in this capacity.
