Article III
3.01 PURPOSES

Guardians of Justice is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. Guardians of Justice's purpose is to participate in community charity events that are centered around children by costuming character identities. Our costuming attire is originally handmade or commissioned and visually represents referenced imagery to the character being portrayed. Handlers are also a crucial piece of our organization that provide support at our events by assisting with safety / audience supervision and photography / videography during events.

We provide education by hosting open discussions and hosting panels at comic and media related conventions, as well as visiting hospitals, schools, libraries, and other public venues. We also utilize social media channels and blogging platforms to provide facts, statistics, event reviews and related data on causes, diagnoses, and current efforts / passion projects.

Our programs include supplying ambassadors to raise social awareness about our causes on a local and global level, in partnership with other organizations as well as hosting our own individual events. We participate in projects and missions that include (yet do not limit our organization to) styling donated wigs for children and families undergoing cancer treatments.

To maximize our impact and current efforts, we may seek to collaborate with other non-profit organizations who also fall under the 501(c) (3) section of the internal revenue code and are operated exclusively for educational and charitable purposes related to our mission.

At the discretion of the board of directors referred to as council members, we provide volunteer opportunities which promote involvement in before-mentioned activities, missions, and programs.
