Article I

The name of this corporation is **In Gideon Shoes Ministry, Incorporated.**

Article II

This Corporation is a nonprofit public benefit corporation and is not organized for private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.

Article III

The specific purpose of this Corporation is to serve as a catalyst to enhance the personal, physical and social development of individuals to prepare them to make decisions about, and making investments in the revitalization of their community, to build opportunity for individuals inclusive of youth to prosper. The primary goal of the Corporation is to increase the value of low-income communities through community and economic development activities such as homeownership, small business development and entrepreneurship education and training. Also the Corporation is established to improve the education, safety, health, and quality of life for seniors, at-risk youth, and individuals living in distressed communities.

Article IV

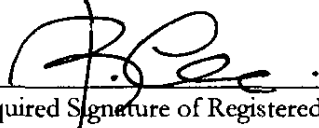

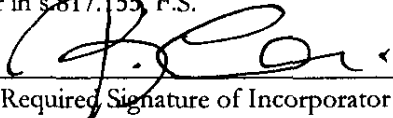
