### ARTICLES OF INCORPORATION

### Article I

The name of this corporation is In Gideon Shoes Ministry, Incorporated.

### Article II

This Corporation is a nonprofit public benefit corporation and is not organized for private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.
