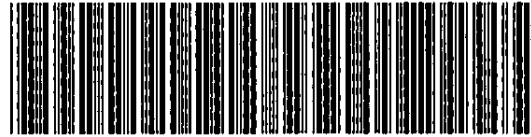

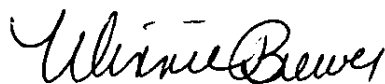

**ARTICLES OF INCORPORATION**

**ARTICLE I**  
**Name**

The name of the corporation shall be: **RIVERVIEW PILOT CLUB, INC.**

**ARTICLE II**  
**Principal Place of Business and Mailing Address**

The principal place of business of this corporation shall be 1209 South Washington Avenue, Titusville, Brevard County, Florida 32780, State of Florida, and its mailing address shall be P.O. Box 16, Titusville, FL 32781.

**ARTICLE III**  
**Purposes**

The purpose for which the corporation is organized are as follows: To serve as a global charitable and educational organization of executive, business and professional leaders working together to improve the quality of life in local communities and throughout the world, and for other lawful purposes permitted under for organizations exempt under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

The business of this corporation shall be managed and its corporate powers exercised by the Board of Directors. The manner in which the directors are elected shall be set forth in the corporation's bylaws and/or standing rules. The manner in which members are admitted shall be set forth in the corporation's bylaws and/or standing rules.

#### **ARTICLE V**

##### **Exempt Activities**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE VI**  
**Dissolution**

Upon dissolution of the corporation, after paying or making provisions for the payment of all liabilities of the corporation, the remaining assets of the corporation shall be distributed exclusively for educational, charitable and scientific purposes or to promote social welfare to one or more organizations qualified as exempt organizations under Section 501(c)(3) of the Internal Revenue Code.

**ARTICLE VII**  
**Amendment to Articles of Incorporation**

These Articles of Incorporation may be amended at any regular or properly noticed special meeting at which a quorum is present, by a two-thirds (2/3) affirmative vote of the members present and voting, provided that written notice has been given to each member no later than thirty (30) days prior to such meeting.

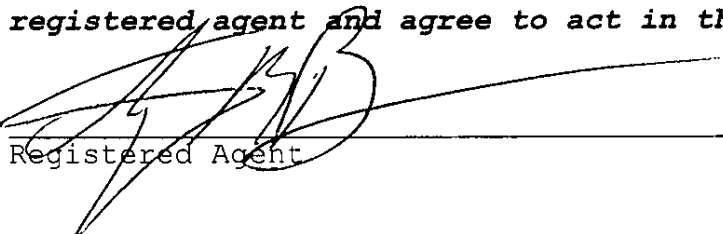

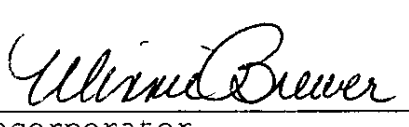
