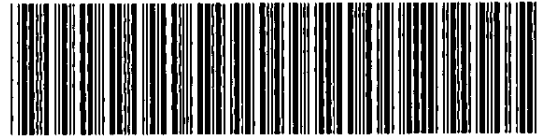

## **CHRISTIAN CITADEL OF FAITH MINISTRIES, INC**

### **ARTICLE III PURPOSE**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the foregoing article hereof

No substantial part of the activities of the Corporation shall be carrying on the propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of, or in opposition to any candidate for public office.

Upon dissolution of the Corporation, the Board of Directors or Trustees shall after paying or making provision for the payment of all liabilities of the Corporation, dispose of all assets of the corporation exclusively for the purpose of the Corporation in such manner, or to such organization or organizations exempt under Section 501 (c) (3) of the Internal Revenue Code of 1954, or the corresponding provision of any future United States Internal Revenue Law, as the board of directors shall determine and as approved by a Justice of the Supreme Court. Any of such assets not so disposed of, shall be disposed of by the Court having jurisdiction thereof in the County in which the principal office of the Corporation is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.
