ARTICLES OF INCORPORATION

OF

GUARDIANS FOR THE MISSING, Inc.

The undersigned incorporator to these articles of incorporation, hereby forms a not-for-profit corporation pursuant to the laws of the State of Florida.

ARTICLE I

NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

The name, address of the principal office and mailing address of the corporation shall be:

ARTICLE II

PURPOSE OF BUSINESS

The purposes for which the corporation is organized are exclusively religious charitable, scientific, literary, and educational within the meaning of s. 501(c)(3)of the United States Internal Revenue Code, or its future progeny and successor legislation (the "Code"). This organization is dedicated to providing underwater investigative searches for missing individuals and loved ones in the hope of solving their disappearances and to bring closure to their families. This organization shall not carry on any activities that are not permitted by an organization exempt from the payment of Federal income tax under the Code.

ARTICLE III

MEMBERSHIP

Qualification of members and the manner of their admission shall be determined in accordance with the corporation's by-laws.

ARTICLE IV

TERM OF EXISTENCE

This corporation is to exist perpetually, commencing on the date these articles are filed with the State of Florida, Secretary of State.

ARTICLE V

REGISTERED AGENT AND INITIAL OFFICE

The Registered Agent and the street address of the initial registered office of the Corporation shall be:

ARTICLE VII

The number of directors may be increased or decreased from time to time in accordance with the corporation's by-laws adopted by the members, but shall never be less than three (3).
