

Article I

Corporation Name

This corporation shall be named: Amar Prem-Sapna Sharanasthan & Basant's Fight for Rare Cancer Awareness, Inc.

Article 11

Duration

The length of time that the organization will be under full function is meant to be nonfinite and perpetual. The existence of our corporation will commence from the initial creation of this non-profit organization.

Article III

Corporate Purposes

The reason for the formation of our organization is to serve the community in various roles that are needed for the growth and prosperity of all humankind, focusing on encouraging spiritual and compassionate views in our daily lives and tasks.

The purpose of our non-profit organization: Amar Prem-Sapna Sharanasthan is to benefit the general public through a Hindu mandir (church) setting. In this aspect, we will promote and instill the values of Sanatan Dharma (Eternal Righteousness) as prescribed in various Vedic scriptures such as the Vedas, Puranas, Upanishads, Shastras, Ramayana, Bhagvat Gita, and other similar texts to this and upcoming generations.

The general goals of Amar Prem-Sapna Sharanasthan include the following: We will host weekly services for Hindu deities as well as festival/holiday events.

2. We will provide a place of learning for the youth to include lessons in Hindi, Sanskrit, Vedic text studies as well as introduction to traditional instruments, bhajans/kirtans (religious choir),

Bharatnatyam/Kathak (religious dance). We will additionally cater to the needs of the youth as Volunteers and funds allow for homework help, SAT prep, etc. We will also strive to provide similar studies catered for adult education for spiritual and general advancement as volunteers and funds allow.

- 3. We will continue to encourage a strong sense of community duties in our members and provide rneans of returning to the community at large through all areas.
- 4. As part of our community growth and outreach, we will aim to provide care for the youth as well as the elderly when financially able.
- 5. We will encourage the students of the community through scholarships as funds allow.
- 6. We will aim to provide a stable environment and place of outreach for less fortunate individuals who may need clothes, food, etc., and social, mental, and financial counseling as financially able.
- 7. We will provide a place of residence for our priest(s) and their immediate family when financially able.
- 8. We will host multiple events throughout the year to help gather needed funds to meet our goals.

Our main goal is to revive Vedic culture and teachings into daily life such as offering Sanskrit prayers (mantras) of gratitude to God and seek His protection in all aspects of our life. Our organization will be subdivided to dedicate specific areas of assistance or interest exclusively including religion, charity, education, and scientific/medical research.

The leadership and guidance of this organization will be provided by a Hindu priest, a religious leader in Sanatan Dharma. This individual will be chosen based on the lineage of their family line as prescribed in the Bhagvat Gita and other texts. The course of study should be completed under an apprenticeship or formal Vedic training. This is in accordance with the fact that Sanatan Dharma is culture which is passed down to each generation through traditions, informal teaching and story-telling from parents and other kin, and formal training and education if this was easily accessible to the individual. In accordance with the law, these individuals should hold the required licensure and/or certificates deemed necessary by the U.S. state and federal government laws and regulations.

The main purpose of the non-profit organization through Basant's Fight for Rare Cancer Awareness is to raise awareness and research towards and for rare cancers. Being Hindus, it is difficult to separate our religion and daily life because Sanatan Dharma is really a culture; therefore, it affects and contributes to every part of life. For example, the grounds on which a building may be crected for our purpose as Basant's Fight for Rare Cancer Awareness would need to be worshipped upon and the building design would directly follow the Vaastu Shastra. It is for this reason that we have establish our Mandir, or church, with our forefront goal of raising cancer awareness and the intent to help societal members in any way possible.

Our incorporator, Basant Tiwary, passed away fighting one of the worst cases of this horrible disease: Desmoplastic Small Round Blue Cell Tumor. The goals of this aspect of the non-profit organization are to continue his fight and honor him in this way by helping those who are also facing cancer, especially rare types, and to push for more sound research dedicated and geared specifically to rare cancers. While we will never turn our backs on an affect person, child or adult, our focus will remain on rare cancers. We will continue to share Basant's story through any possible means such as through news articles, social media, meetings, etc. We will encourage those who wish to volunteer or provide financial support through general outreach to the community. Activities and organizations that we will coordinate with include the Share-A-Meal program at the Ronald McDonald Houses or providing gas/gift cards to social workers/child life specialists/hospital nurses that can be given to needed families. As our financial growth allows, we will also aim to provide funding for necessary rare cancer research including the rare cancer which Basant was diagnosed and treated for unsuccessfully. Once again, this part of the organization will be exclusively devoted to religion, charity, education, and scientific/medical research.

Under both entities of our non-profit organization, we will pursue:

- A) Education of society through traditional school environments including educational field trips,
- B) Collaboration with other organizations holding similar values to work towards our goals,
- C) Acquisition of real or personal property for the exclusive purposes of our organization.

Under both entities of our non-profit organization, we will use corporation powers for:

(A) The receipt and acceptance of monetary and property gifts for organization benefits only

- B) The raising and assistance of funding for the organization including bonds and forms of credit
- C) The acquisition, acquirement, leasing, mortgaging and disposition of real and personal property
- D) The conduction of services and informative discussions through any and all forms of public media
- E) The acceptance of various donations and property in trust for religious and charitable purposes
- The acquisition, holding, owning, selling, assigning, transferring, mortgaging, pledging, or other disposition of capital stock, bonds, obligations, or other shares and/or other securities of other corporations, as investment or otherwise, either foreign or domestic, carrying out the purpose of the organization, exercising all privileges, powers, and rights of ownership, including the power to Note, while the owner thereof.

Our non-profit organization holds sole ownership and rights to include publication, to all projects, works, and discoveries specifically completed for Basant Tiwary, Amar Prem-Sapna Sharanasthan, and Basant's Fight for Rare Cancer Awareness. This work include music, literature, tapes, artworks, choreography, scientific discoveries, and any other form of intellectual property. If so agreed upon mutually prior to intellectual property completion, compensation will be given to the individual or group for the time and dedication to the particular work completed. If so desired, copyrights, patents, and trademarks will be pursued and obtained by our non-profit organization.

The property of our non-profit organization is dedicated to religious, education, scientific/medical research, and charitable purposes irrevocably. No part of the net earnings shall benefit, be distributed to, private personas, members, trustees, directors, or officers. The organization shall be privileged, authorized, and empowered to make payments and distributions and to pay reasonable compensation for services rendered in accordance with IRS Section 501(c) (3).

Our non-profit organization will refrain from:

- A) Any and all types of political opinions, campaigning, or support for any candidate
- B) Operating as a for-profit business or carrying on any type of trade
- C) Endangering exemption status by wrongful accumulation, investment, or diversion of income
- D) Engaging in any activities or practicing powers that are not compliance with IRS 501 (c)(3)
- E) Conducting operations that are not principally done in the United States of America.

Our non-profit organization is meant to comply and implement all present and future local, state and federal laws, including those of the Department of Revenue (DR-5) and the Internal Revenue Service (501(c)(3)), regarding churches, public charities, and/or non-profit organizations.

In the most simplistic definition, our goal of this non-profit organization to is help all mankind and promote righteousness. Our non-profit: Basant's Fight for Rare Cancer Awareness is dedicated to Basant's story and life. Our goals are to help families dealing with cancer, no matter color, creed, race, religion, etc. and raise funds for rare cancer research. We would like to have a community building to accommodate struggling families with medical bills/financial strain due to a cancer diagnosis, and also provide a non-discriminatory place for children of all ages to communicate and engage with one another, especially when going through this type of ordeal. Our non-profit: Amar Prem-Sapna Sharanasthan, so named for Prem (love) and Sapna (dream)-the names Basant chose for his future children, is dedicated to serving the community at large. We would like to encourage a Hindu community that follows in the steps of the Christian churches. There are no local Hindu mandirs (churches) that provide daycares, schooling, counseling, financial aide, scholarships, food -pantries, etc. We do not think that this is right because funds raised stay within the mandir and mever reach the people. While not everyone is in need, there are numerous families that are. We want to encourage a deeper sense of purpose towards healthy community growth and develop and encourage unity and compassion of mankind. We hope to have a building that will allow us to function in these aspects as well. Although we've already lost Basant, it doesn't mean that we cannot help people that are still here on Earth and need the help that Basant once did. Because Basant's philosophy, was "Don't just sit and pray, go out and do something, help someone," we have taken his teachings in stride and have repurposed ourselves to do such. The founding Board Members will ensure that message is poured into the community with everything that we do under Amar Prem-Sapna and Basant's Fight for Rare Cancer Awareness, Inc.

To fully comply with the legalities of the Internal Revenue Service for non-profit organizations rightfully seeking tax exemption status, Amar Prem-Sapna Sharanasthan & Basant's Fight for Rare Cancer Awareness, Inc. have adapted and; therefore, amended our purpose to include the following quoted clause: "The organization is organized exclusively for charitable, religious,

educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code."

Article IV

Registered Office and Agent

Article V

Corporate Affairs Management

The business, affairs, and powers of the organization will be managed and exercised under the authority and direction of the Board of Directors, of which (3) directors shall permanently be installed. If necessary and approved by the majority of directors, more members may be added to or withdrawn from the position of director, but no less than (3) directors will serve at any given time.

The Bylaws of Amar Prem-Sapna Sharanasthan & Basant's Fight for Rare Cancer Awareness are as follows:

Adopted April 28, 2018, all officers and directors will be appointed or elected based on the nature of the position. Any positions, given or chosen, should be granted according to the knowledge of the individual on the non-profit organization's needs and the ability to complete the necessary tasks with competence. When required, additional positions may be created to effectively fulfill the goals of the

The general code of conduct for all individuals including members, those on the Board of Directors, or any other roles of leadership given at any point in time is to always act selflessly and solely for the purpose and benefit for the non-profit organization and it's goals. Any individual found to have a conflict of interest will be placed in a different position or removed depending on their effect to the organization. No personal gain should be achieved via this conduct except impeccable character, gaining trust and respect from each other and even non-members of the non-profit organization. Compensation and bonuses will be given on based on knowledge, experience, and merit, and will not be based on any bias. Any individual who can not or will not uphold this simple and straightforward role should be removed from their position and a replacement shall be appointed or elected as deemed fit by the remaining Board of Directors and/or members. These bylaws will not change, but if needed, will be amended by the Board of Directors to give further clarity to any given role or position.

Article IX

<u>Amendments</u>

In accordance with the Bylaws of this corporation, Amendments may be adopted by a majority of directors to these Articles of Incorporation and Articles of Amendment.

Miscellaneous

If for any reason, our non-profit organization: Amar Prem-Sapna Sharanasthan & Basant's Fight for Rare Cancer Awareness, Inc. is unable to carry on for reasons unknown, we would relinquish all religious aspects to state- and federally complying Hindu organizations and all medical and charitable aspects to all state- and federally complying hospitals, community centers, shelters, and orphanages as deemed fit by the remaining members of the organization and/or the local, state, and/or federal government, including the Department of Revenue and the Internal Revenue Service, in accordance with all present or future laws.

Once again, to fully comply with the legalities of the Internal Revenue Service for non-profit organizations rightfully seeking tax exemption status, Amar Prem-Sapna Sharanasthan & Basant's Fight for Rare Cancer Awareness, Inc. have adapted and; therefore, amended our dissolution to include the following quoted clause: "Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose."

We, the establishing members of the Amar Prem-Sapna Sharanasthan & Basant's Fight for Rare Cancer Awareness, Inc., hereby agree to continuously commit and comply to the above defined Articles of Incorporation and Articles of Amendments of our non-profit organization.
