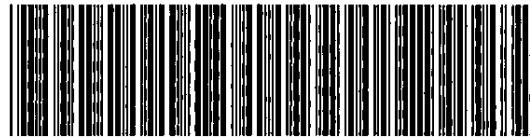



The undersigned, acting as the incorporator of a Corporation pursuant to Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation of such Corporation.

FIRST: The name of the corporation (the "Corporation") is:

**VIETNAM MEMORIAL FOR COLLIER COUNTY, INC**

SECOND: The street address of the corporation's registered office, initial principal office, and the mailing address of the Corporation is:

THIRD: The purposes and objectives for which the Corporation is organized are:

1. The purpose of the Corporation is to honor veterans that served in Vietnam, especially those killed in action or missing in action, by raising money, purchasing and placing a monument to them in Naples, Collier County, Florida.. The Corporation will raise funds to purchase and place the monument in Collier County. Maintenance of the monument will become the responsibility of the property owner where the monument is placed.
2. To do any and all things necessary and appropriate to accomplish or implement the foregoing purpose.
3. The Corporation's purposes are hereby limited in such a manner as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended ("Code"), or under corresponding provisions of any subsequent federal tax laws.

FOURTH: The method of the election of directors of the corporation shall be as stated in the Bylaws of the Corporation

There is no provision which limits the manner in which the Corporate powers are authorized under this act.

All actions taken by or on behalf of the Corporation shall be consistent with the laws of the State of Florida.


