

ARTICLES OF INCORPORATION OF TRINITY ROTARY CHARITABLE FOUNDATION, INC.

ARTICLE I. - NAME

The name of this corporation is Trinity Rotary Charitable Foundation, Inc.

ARTICLE II. - PRINCIPAL OFFICE

The street address of the initial principal office and the mailing address of the corporation is: 7512 Ridge Road, Port Richey, FL 34668.

ARTICLE III. - PURPOSE

This corporation is organized under the not for profit laws of the State of Florida and is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV. - MANNOR OF ELECTION

The affairs of the Corporation will be managed by a Board of Directors. The number of members of the Board of Directors will be determined by the bylaws of the corporation but shall not be less than one. The number of directors may be either increased or diminished from time to time by the By-Laws, but shall never be less than one. The directors shall be elected or appointed, and the method of election or appointment of the directors shall be as provided in the bylaws of the corporation.

ARTICLE VII. - EXISTENCE & COMMENCEMENT

This corporation shall have perpetual existence and its existence shall commence upon the filing of these Articles.

<u>ARTICLE VIII. – INDEMNITY OF OFFICERS & DIRECTORS</u>

The corporation shall indemnify any officer or director to the full extent permitted by law.

<u>ARTICLE IX. – INCORPORATOR(S)</u>

The name and address of the incorporator signing these Articles is as follows: Barry Poppel, PO Box 238, New Port Richey, FL 34656-0238.

ARTICLE X.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE XI.

Upon the dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future tax code), or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such Corporation or Corporations, as said Court shall determine, which are organized and operated exclusively for such purposes.
