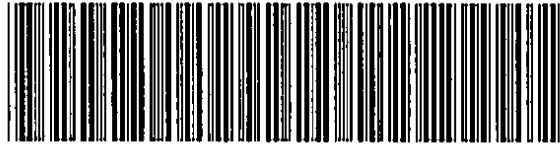

The name of this corporation shall be Iglesia Cristiana Amamos A La Gente, Inc.


Amendments Adopted
