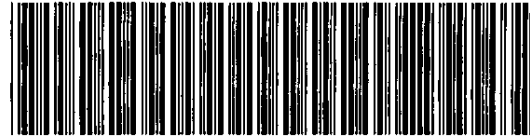

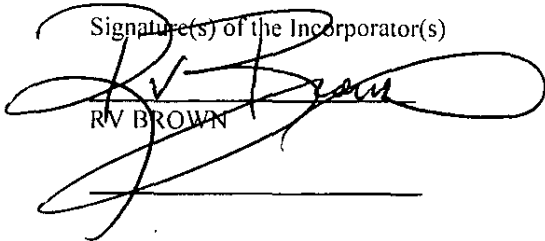

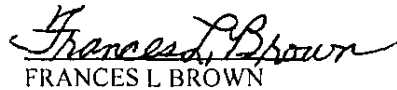
ARTICLE IX - DISSOLUTION OF THE CORPORATION

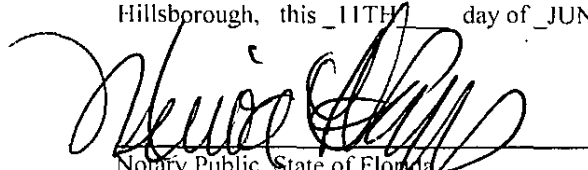

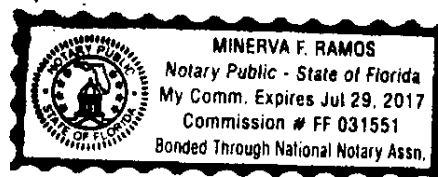
