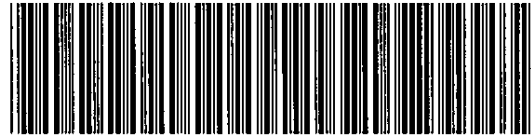

Article I The name of the corporation is: Pratville Alumni Overseas Chapter, Inc.

Article III The specific purpose for which this corporation is organized is: The general purpose or purposes is/are to

is exclusively for charitable and educational purposes, consulting and all other lawful business activity for which the
Corporation may be incorporated under Chapter 607 of the Florida statutes.

A. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not
permitted to be carried on by an organization exempt from Federal income tax under section 501C(3) of the
Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

B. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the
meaning of 501C(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal Tax Code,
or shall be distributed to the Federal, State, or Local government for a public purpose. Any such assets not so
disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of
the organization is then located, exclusively for such purposes.
