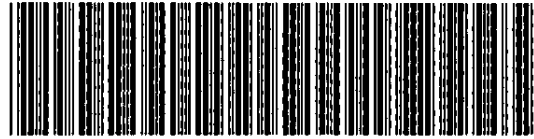

**The articles of incorporation for Anointed Winter Park District, Inc.**

**The articles were adopted/approved by the board of directors on April 4, 2014. No members were needed to vote.**

**Article One**

**The name of the Corporation shall be Anointed Winter Park District, Inc.**

**Article Two**

**The principle place of business of the corporation is located at 733 West Lyman Avenue, Winter Park, FL 32789. Offices may also be maintained at such other place or places, either within or outside of the State of Florida, as may be designated from time to time by the Board of Directors.**

**The mailing address for the place of business of the corporation is 4800 Vanguard Street, Orlando, FL 32819.**

### **Article Three**

**The following are the purposes for which this organization has been organized.**

**The purpose for which the corporations is organized are to naturally and spiritually preach, teach and demonstrate the Full Gospel of Jesus Christ by evangelistic outreach to all people of all races, colors, creeds and international regions. Also to create a social unit of people that is structured and focused on building a community that is morally sound and is collectively seeking a positive atmosphere for ourselves as well as our future children.**

**We believe that through the word of God, and with love and kindness we can draw ones who's hearts have been corrupted by the immorality of the world.**

### **Article Four**

**The Superintendent of a District is appointed by the Western Florida Jurisdictional Bishop. The Board of Directors was appointed by the Superintendent of the District. The**

**Superintendent of Directors may revoke the appointment of such agents at any time and shall have the power to fill any vacancy.**

**The Assistant Superintendent is appointed by the Superintendent.**

**The District Missionary is appointed by the State Women Supervisor.**

**The following positions are appointed by the Superintendent of the District:**

**District Evangelist**

**District Sunday School Superintendent**

**District Youth President**

**District Musician**

**Candidates for the officers/directors are an open election that will be ultimately decided by superintendent. Each candidate for election has to be an active member in their church and district functions.**

- . Each candidate must have a letter of recommendation from their pastor.**
- . Each candidate position will be good for one year.**

**You Initial Officers and/or Directors must apply annually.**

- . If a candidate fails to fulfill their duties they will be removed from the position immediately.**
- . If any candidate conducts in any obscene or immoral acts, they will be removed from office immediately.**




