ARTICLES OF INCORPORATION 14 JUN 23 PM 4: 32 OF FOREST HILL CEMETERY ASSOCIATION, INCRETARY OF STATE A Not For Profit Corporation TALLAHASSEE, FLORIDA

ARTICLE I NAME

The name of the corporation shall be Forest Hill Cemetery Association, Inc.

ARTICLE II EFFECTIVE DATE

The effective date of this corporation shall be the date of filing these Articles of Incorporation.

ARTICLE III PRINCIPAL PLACE OF BUSINESS
