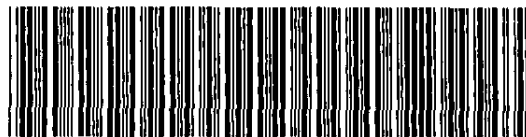

**ARTICLE I - NAME**

The name of this corporation is Divine Day Care and Learning Center, Inc.

**ARTICLE II - PRINCIPAL OFFICE**

The street address of the principal office of the Corporation 773 Adolphus McMillan Rd; Chattahoochee, Florida 32324

The mailing address of the principal office of the Corporation 2740 East River Road; Bainbridge, Georgia 39817

**ARTICLE III - PURPOSE**

This corporation is organized exclusively for charitable, religious, scientific and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or the corresponding provision of any future United States Federal Revenue Code), including, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code ( or the corresponding provision of any future federal tax code). In furtherance of such purposes, the corporation is organized to proclaim the gospel of Jesus Christ and to seek to meet the spiritual, financial, charitable and physical needs of the community to the glory of God.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office to any extent whatsoever.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any

other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation of the purposes of this corporation."

#### **ARTICLE IV- MANNER OF ELECTION**

The directors are elected and/or appointed in accordance with Bylaws . A director must be 18 years of age. The names and addresses of the persons appointed to act as the Initial Directors of this corporation are listed in Article V.

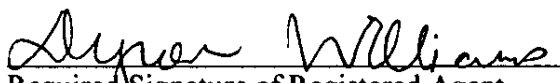

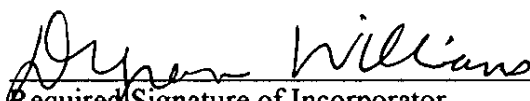

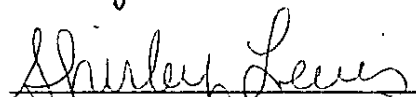
