ARTICLE I – NAME

The name assumed by this corporation and by which it shall be known in law is Lamb of God Church and Unshackled Ministries Incorporated.

ARTICLE II - ADDRESS

The current principal place of business address of the corporation is 155 Custard Ct. Lot 1 Pahokee, Florida 33476. The mailing address is P.O. Box 218 Canal Point, Florida 33438

ARTICLE III – PURPOSE

- A. The purpose of the organization shall be exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the building, maintaining and operation of churches, parsonages, schools, chapels, radio stations, television stations, rescue missions, print shops, day care centers, camps, nursing homes, and cemeteries, and any other ministries that the Church may be led of God to establish.
- B. The church shall also ordain and license men to Gospel ministry; evangelize the unsaved by proclaiming of the Gospel of the Lord Jesus Christ; educate believers in a manner consistent with the requirements of the Holy Scripture, both in Sunday and weekday schools of Christian education: maintain missionary activities in the United States and any foreign country; and engage in any other ministry that the church may decide, from time to time, to pursue in obedience to the Will of God.

ARTICLE IV - GOVERNMENT

SECTION 1 - SOVEREIGNITY OF THE BODY

The Lamb of God Church and Unshackled Ministries shall remain a sovereign body in itself. It shall have its own Board of Trustees and be responsible for its finances, deportment and conduct.

SECTION 2 – CHURCH GOVERNMENT

The government of the Lamb of God Church and Unshackled Ministries rests in the self-perpetuating of The Moderator. The three denominational officers are: The Moderator; Secretary; and Treasurer. The Moderator, from time to time as deemed appropriate, may appoint other denominational officers, board or commissions.

SECTION 3 – DESIGNATION OF CORPORATE OFFICERS

As an accommodation to legal relationships outside the denomination the Moderator shall serve as president of the corporation, the Secretary will serve as secretary of the corporation; and the Treasurer shall serve as the treasurer of the corporation.

SECTION 4 - ELIGIBILITY FOR ELECTION TO OFFICE

Whenever a vacancy occurs on the Board of Trustees, the remaining members of the board shall elect a successor from those in general membership and or a denomination that adheres to the "Articles of Faith" designated in Article VIII, who are ordained or licensed ministers and to the Constitution and By-Laws set forth by this denomination.

SECTION 5 - TERMS OF OFFICE

A. Members of the Board of Trustees shall serve for a term of three years unless said membership is dissolved at the option of the individual or the board by giving a month's notice, or less by mutual consent. The severance of a board member's service may be considered at any regular board meeting, provided that appropriate notice of the meeting has been given. At least three members of the board shall required to decide the matter.
